<u>CALL TO ORDER</u>: Chairman Moyer called the regularly scheduled meeting of the Washington Township Board of Supervisors to order at 7:04 p.m., at the Washington Township Municipal Building. The meeting opened with the Pledge of Allegiance.

TAPING OF MEETING

The meeting was recorded as an aid in the preparation of the minutes. It was noted no one other than the Township Secretary was taping the meeting this evening.

AGRICULTURAL SECURITY AREA HEARING

This is the time, place and date advertised for the addition of the property located at 2213 Old Route 100, Washington Township. Application was received on 3/2/2022, notice was published in the Reading Eagle on 3/18/2022. There were postings in five (5) conspicuous locations by the LTL Code Official. On 3/24/2022 the Board of Supervisors acknowledged the receipt for proposal of modification at the Board of Supervisors meeting, followed by a 45-day review and comment period. On 5/20/2022 notice of tonight's hearing was published in the Reading Eagle and also written notice given to the property owners. Solicitor London read into the hearing minutes, Exhibit 1 thru Exhibit 15 for the record. The property owners were present this evening and stated they want to keep the property as natural as possible.

A motion was made by Thomas Powanda, seconded by David Moyer accepting Resolution No. 2022-22 modifying the existing Agricultural Security Area to include parcel ID #89-5399-03-41-2024 16 acres at 2213 Old Route, Barto, Washington Township.

- Basketball Court painting It is reported the painting will take five (5) days which is scheduled for the end of July and are looking for five (5) people to assist. The pricing has been updated to \$7,678.17 which will need to be reauthorized. Supervisor Powanda requested posting of signs indicating the court will be closed for one week for maintenance. A motion was made by David Moyer, seconded by Romnie Long authorizing the updated cost of painting to \$7,678.17.

- Recycling Center operations contract Rich stated the township has not yet signed the contract offered by Cougles however Rich did speak with them about a month to month contract for the time being. Rich did have Total Recycling come out to look at the site and they will provide a quote.
- Trees removals Rich received a third quote, the lowest quote for the removal of two (2) Ash trees in Washington Park, seven (7) Ash trees that circle the Weinsteiger Pump Station is from Dallas Tree Service Inc. A motion was made by David Moyer and seconded by Thomas Powanda authorizing Dallas Tree Service Inc to do the tree removal as outlined for a cost of \$6,300.
