Camp Camino Conditional Use application - Conversion of barn structures.

Mr. Weber stated there is a lengthy application submitted however there is no plot plan with the application. Ms. London explained the Board of Supervisors are looking for the Planning Commissions comments and recommendation on this application as the Conditional Use Hearing is scheduled for Thursday, November 17th. Ms. London said this application is for the conversion of the barns and barn conversions are allowed as a conditional use. The proposed conversions are for one barn to be converted to a residence and the second barn to be used as a gathering or meeting barn. Is there any assurance that the barns will remain strictly for family use? Ms. London said the condition in the decision would say the structures will be used for personal, household and family use only and not to be utilized for any type of commercial use. This gives the township the ability to enforce. The Plan shows one office in the lower level, a gym and a utility room and the upper level is one large open room.

A motion was made by Mark Bedle, seconded by Jennifer Cunningham recommending approval of the Camp Camino Conditional Use application based upon compliance with the review letter comments contained in the LTL review letter dated October 27, 2022 and with the understanding the property is to be used solely for the purpose of personal, family and household use of the applicant.
