# WASHINGTON TOWNSHIP BOARD OF SUPERVISORS MINUTES JANUARY 26, 2023

<u>CALL TO ORDER</u>: Chairman Powanda called the regularly scheduled meeting of the Washington Township Board of Supervisors to order at 7:00 p.m., at the Washington Township Municipal Building. The meeting opened with the Pledge of Allegiance.

#### **ROLL CALL**

# **TAPING OF MEETING**

The meeting was recorded as an aid in the preparation of the minutes. It was noted no one other than the Township Secretary taping the meeting this evening.

#### SPECIAL REQUEST

**John Backenstose, Clover Hill** – Mr. Backenstose stated the Clover Hill development is built out with the only remaining item is the basin on lot #6. Mr. Backenstose is requesting dedication with basin escrow. Mr. Weber said there would need to be a separate agreement with security to complete the basin and this would be executed along with the deeds of dedication.

A motion was made by David Moyer, seconded by Romnie Long authorizing the preparation of the escrow agreement for the basin located on lot #6 in the Clover Hill Subdivision in the amount of \$10,000.

#### FIRE CHIEF'S REPORT

A copy of the Eastern Berks Fire Department and Bally Ambulance reports is enclosed.

Chief Mutter reported the 2022 year ended with 502 calls and thanked the Township for their continued support. Chief Mutter stated they are still in negotiations with the church and the property owner on the parcel of land they wish to purchase to construct a new fire station. Chief Mutter explained EBFD has recently been called to the Washington Inn by automatic alarm and have had trouble gaining access to the building. The Chief explained other local municipalities have a Knox Box Ordinance and is requesting the Township enact an ordinance that any commercial establishment with an automatic alarm system in the township have a Knox Box so the fire department is able to gain access to the property. Information was provided to Rich along with a sample ordinance. The boxes would be purchased and installed by the property owner however the fire department would come out to make sure the box works and possibly tour the facility. In addition, they have recently come out with red address signs at a cost of \$10. The red color indicates there is something different at this location such as accessibility issues, handicapped resident, etc. Romnie suggested putting this information in the township newsletter.

Chief Mutter also expressed concern regarding trees overhanging on Route 100 near Mill Street.

Rich thanked the EBFD for providing the township with a gas meter which has been used for the past few weeks.

# **SEWER ENGINEER'S REPORT**

• Request to Bally Borough to amend Intergovernmental Sewage Agreement – Bally Borough is requesting to not only revise the service area but also to update the sewer agreement. Mr. Unger stated he is also the Engineer for the Borough of Bally and Bally did not have an issue with SDE representing the borough and wanted to put this on record as a conflict.

A motion was made by Romnie Long, seconded by Thomas Powanda to waive the conflict for SDE to represent Washington Township and Bally Borough for the Sewage Agreement.

- PADEP closure of Weinsteiger Corrective Action Plan Semi-annual report filed with PADEP and provided documentation for the Consent Order Agreement to be closed. PADEP upon their review accepted the request and responded there are no connection restrictions to the pump station and the Corrective Action Plan is considered closed.
- WWTP purchase of pump & charger for gas meter There is a sample pump available for the gas meter which Rich would like to purchase as well as a wall charger. A motion was made by David Moyer and seconded by Romnie Long authorizing the purchase of a sample pump and wall charger not to exceed \$550.

• WWTP cleanup of Aluminum Chloride building – Over the years there have been spills with absorbent material being put down. The material must be cleaned up and new totes installed. Rich has obtained price quotes for the cleanup.

A motion was made by David Moyer and seconded by Romnie Long authorizing the clean up of aluminum chloride by Elk Environmental Services with a cost not to exceed \$6,000.

#### **TOWNSHIP ENGINEER**

Mr. Weber reported the Eddinger Land Development Plan was accepted by the Planning Commission to be reviewed at the March Planning Commission meeting.

 2023 Road Project bid opening – Two bids were received and opened on Monday. One bid was from EJ Breneman in the amount of \$125,396.50 and the second bid was from Recon Construction Services in the amount of \$93,571.25.
 A motion was made by David Moyer, seconded by Romnie Long awarding the 2023 Road Project to Recon Construction Services in the amount of \$93,571.25 subject to their submission of the required Payment Bond, Performance Bond and Certificate of Insurance.

• Barto Road straightening project – comments were received back from Buckeye Pipeline and responded to their comments and resubmitted plans to them. The Plans were resubmitted to the Berks County Conservation District for the NPDES Permit and a temporary construction easement will be needed from Padre Pio for installation of temporary erosion and sediment control facilities for which Joan has prepared an agreement.

A motion was made by Romnie Long, seconded by David Moyer authorizing the execution of the temporary construction easement agreement with National Centre Padre Pio.

• Prestige Property Partners sewage service agreement – The agreement has been prepared with the final version included in the agenda packet. This is for both the reservation of capacity for phase 1 of the Edison Walk development as well as for Plant expansion. There will be a meeting on 2/1/23 regarding the schedule of connections and the availability of edu's.

A motion was made by David Moyer and seconded by Romnie Long authorizing the execution of the Sewer Service Agreement between Washington Township and Edison View Partners.

Prestige Properties, agreement for maintenance costs of stormwater facilities
related to PADOT Highway Occupancy permit – Prestige has requested the
Township to sign the applicant authorization for the agent to apply for Highway
Occupancy Permit. The prepared agreement indemnifies the township for any
costs or liability.

A motion was made by Romnie Long, seconded by Thomas Powanda authorizing the execution of the agreement for maintenance costs of stormwater facilities related to PADOT Highway Occupancy Permit.

- Washington Pub wastewater citation appeal There was a hearing held in December for sewage violations. Mr. Satiro has filed an appeal and that hearing will be held on March 7<sup>th</sup> at 1:30 p.m. courtroom #9 at the Berks County Courthouse.
- Mingey Settlement Agreement amendment Some of the properties have been purchased by third parties the settlement agreement needs to be assigned to those

parties and needs to be amended to reflect those parties being subject to the settlement agreement.

Motion was made by David Moyer and seconded by Romnie Long to execute the stipulation to amend the settlement agreement.

# UNFINISHED BUSINESS

- County Line Road, traffic calming Mr. Moyer spoke with Boyertown Transportation to see if the bus stop location will be changed. They indicated there will be no change. Mr. Moyer suggested parents attend the schoolboard meeting.
- Nighttime sign audit ongoing
- **Public Works garage project** Updated price quotes have been received for the building and also for boring and soil testing. A motion was made by Romnie Long, seconded by David Moyer accepting the price quote from Earth Engineering Inc. in the amount of \$6,175 for project coordination and management, field investigation, laboratory testing and analysis and report preparation.

Dave has been talking with Precise Concrete regarding poured 4-foot walls which the building would be placed or built upon. After some discussion it was decided to go with the steel building rather than a pole building. A motion was made by Thomas Powanda authorizing SDE to draft plans for the construction of the Public Works building, motion seconded by David Moyer.

- **Public Works position/hiring** The position has been filled however there is another budgeted position which would be half time at WWTP and half time at Public Works. The Board would like to move ahead to fulfill the position. Rich will check availability and get back to Board Members.
- **Appointment of Herbein** + **Company** Motion made by Romnie Long and seconded by Thomas Powanda authorizing the advertisement of Herbein + Company as the Township Auditing Firm for the 2022 Audit.

Mr. Moyer stated the township has elected Auditors and asked the Solicitor what their function is and does the township need appointed and elected auditors? Ms. London explained the Board of Auditors shall not audit, settle or adjust the

accounts of the township audited by the appointed auditing firm. The duties of the elected auditors are to set the compensation for current year Supervisors employed by the township. Rich said the auditors have made a request of the Board of Supervisors to attend the presentation of the 2022 audit results by Herbein. After some discussion it was stated the audit review is done in a public meeting and the elected auditors may attend the meeting if they so desire.

# **NEW BUSINESS**

• Enbridge Road Use Permit extension – A motion was made by Romnie Long, seconded by Thomas Powanda authorizing the extension of the Enbridge Road Use Permit through 2023.

Romnie Long-aye Thomas Powanda-aye David Moyer-abstained

 Road Occupancy Permit, Stauffer Road –This is related to a sewer main installation on Stauffer Road for a fee of \$295.50. A motion was made by David Moyer, seconded by Romnie Long authorizing the Road Occupancy Permit for Spring Valley Village at Stauffer Road.

• **Brush Chipper purchase** – The Chipper would be gas powered with a winch attachment. A motion was made by David Moyer, seconded by Romnie Long authorizing the purchase of the Morbark Eeger Beever 1415 Brush Chipper in the amount of \$64,321.53.

A motion was made by Romnie Long, seconded by Thomas Powanda authorizing the sale of the old chipper on Municibid with a starting bid of \$1,500.

#### All ayes

• Right of way removal of ash trees, scope/budget/purchasing – Brian has been obtaining price quotes for the removal of dead ash trees at identified locations within the township. The quotes are approaching \$100,00 and this is an expense that is not budgeted. Brian said the trees on Wilt Road should be taken down first and Weisstown Road should be second. Rich suggested to finish up identifying hazardous trees and give more thought to where the wood can be left. Break the project up into areas and also look into funding of the project. A motion was made by David Moyer and seconded by Romnie Long authorizing setting a budget of \$7,500 for emergency tree removal and approving a quote from Dallas Tree Service of \$5,100 for the removal of six (6) trees on Wilt Road.

- **File cabinet purchase for active subdivision plans** A motion was made by David Moyer, seconded by Thomas Powanda authorizing the purchase of a lateral file cabinet from Quill in the amount of \$1,044.99.

• Pottstown Health & Wellness grant application – Rich has been working with the consultant and reported there is a window opening up for grant applications for a 50/50 grant for ADA accessibility. The letter of intent would include the guiderail, engineering, PADOT permit for the crosswalk, installation of crosswalk and ADA pads around benches and tables in the park system. A motion was made by David Moyer and seconded by Thomas Powanda authorizing the Manager to submit the letter of intent and work on the scope of the project.

• Montco Fence quote for Barto Park fence repair – The damaged fence is due to a fallen ash tree. This has been submitted to the insurance company and they indicated this is likely covered with a \$500 deductible. Motion made by Romnie Long, seconded by David Moyer authorizing the repair to the fence in Barto Park at the basketball court by Montco Fence Co. in the amount of \$3,979.
