Richard Black Minor Plan – submitted 1/31/2023

• LTL Review Letter – dated 4/25/23

Present this evening is Mr. John Hoffert representing the Richard Black Minor Plan located at the corner of Kulps and Hillcrest Roads. Mr. Hoffert explained lot #4 of the Franola Subdivision would be divided into two lots creating an additional lot #5. Richard Black Jr. is the applicant of this proposed plan. A review of the LTL review letter was conducted and Mr. Hoffert distributed a waiver & deferral request letter which addressed a number of the LTL review comments. Mr. Stauffer stated he believes the original plan was submitted as a seven (7) lot subdivision which conformed to the township zoning

however PADEP said because of the high level of nitrates they would only allow four (4) lots and how does that ruling impact this subdivision. Mr. Weber stated a new Planning Module must be submitted to PADEP for review and consideration. Mr. Hoffert explained Warmkessel Environmental has been retained to do a complete hydro study to be submitted to the Township, LTL Consultants and to PADEP. Mr. Hoffert noted the setting of concrete monuments will be done prior to final plan approval. Following are the motions for the waiver/deferral requests:
